Welcome to PS PEARL Premium Suites. We respect your privacy and are committed to protecting your personal data. This Privacy Policy informs you how we look after your personal data when you visit our website <https://pearl-suites-limassol.com> (the "Site"), make a direct booking request, or stay at our residence. It also tells you about your privacy rights and how the law protects you.

1. IMPORTANT INFORMATION AND WHO WE ARE## Data Controller

JODEMOR HOLDINGS LTD / PS Pearl Premium Suites is the data controller and responsible for your personal data (collectively referred to as "PS PEARL", "we", "us" or "our" in this Privacy Policy).

2. THE DATA WE COLLECT ABOUT YOU

Personal data means any information about an individual from which that person can be identified. We may collect, use, store and transfer different kinds of personal data about you which we have grouped together as follows:

- * Identity Data: Includes first name, last name, passport number, national identity card details, or date of birth.
- * Contact Data: Includes email address, telephone number, and WhatsApp ID.
- * Booking & Stay Data: Includes details about your check-in/check-out dates, guest count (adults, children, infants), suite preferences, and arrival time.
- * Financial Data: Includes payment card details and billing information (collected securely if you complete a transaction).
- * Technical & Usage Data: Includes internet protocol (IP) address, browser type, time zone setting, and how you use our Site.

3. HOW YOUR PERSONAL DATA IS COLLECTED

We use different methods to collect data from and about you, including through:

- * Direct Interactions: You give us your Identity, Contact, and Booking Data by filling in the booking request forms on our Site, or by communicating with us via email, phone, or WhatsApp.
- * Automated Technologies: As you interact with our Site, we may automatically collect Technical Data about your equipment, browsing actions, and patterns using cookies and similar technologies.

4. HOW WE USE YOUR PERSONAL DATA

We will only use your personal data when the law allows us to. Most commonly, we use your personal data in the following circumstances:

- * To fulfill your booking request: To manage your reservation, assign your suite, and facilitate keyless access codes.
- * To comply with legal obligations: To register your stay in accordance with Cyprus local tourism and immigration laws.
- * Customer Support: To notify you of updates regarding your stay and respond to your preferences or inquiries.

5. DISCLOSURES OF YOUR PERSONAL DATA

We do not sell your personal data. We may share your personal data with internal staff and selected trusted third parties strictly necessary to perform our services:

- * Service Providers: IT professionals, web hosting providers, and communication tools (such as WhatsApp) that help run our website and guest communication.
- * Legal Authorities: Authorities and law enforcement bodies in Cyprus if required under local statutory obligations.

6. DATA SECURITY

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used, or accessed in an unauthorized way. Access to your personal data is restricted to employees and managers (such as the resident host team) who have a business need to know.

7. DATA RETENTION

We will only retain your personal data for as long as reasonably necessary to fulfill the purposes we collected it for, including for the purposes of satisfying any legal, regulatory, tax, accounting or reporting requirements.

8. YOUR LEGAL RIGHTS

Under the GDPR and EU data protection laws, you have specific rights in relation to your personal data:

- * Request access to your personal data.
- * Request correction of your personal data.
- * Request erasure of your personal data ("the right to be forgotten").
- * Object to processing or request restriction of processing your personal data.
- * Request transfer of your personal data.
- * Withdraw consent at any time where we are relying on consent to process your data.
